**PENALTIES FOR FIRST VEHICLE CODE § 14601.3 WITHIN 7 YEARS**

  - Up to 30 days in county jail.
  - Fine of up to \$1,000.
- 14. PROBATION DENIED
  - 30 days in county jail, and
  - Fine of \$1,000.

**PENALTIES FOR SECOND OR SUBSEQUENT VEHICLE CODE § 14601.3 WITHIN 7 YEARS**

- 15. PROBATION GRANTED
  - Up to 180 days in county jail.
  - Fine of up to \$2,000.
- 16. PROBATION DENIED
  - 180 days in county jail, and
  - Fine of \$2,000.

**PENALTIES FOR FIRST VEHICLE CODE § 14601.5 WITHIN 5 YEARS**

- 17. PROBATION GRANTED
  - Up to 6 months in county jail.
  - Fine of up to \$1,000.
- 18. PROBATION DENIED
  - Up to 6 months in county jail.
  - Fine of \$300 to \$1,000.

**PENALTIES FOR SECOND OR SUBSEQUENT VEHICLE CODE § 14601.5 WITHIN 5 YEARS**

- 19. PROBATION GRANTED
  - Up to 1 year in county jail.
  - Fine of up to \$2,000.
- 20. PROBATION DENIED
  - 10 days to 1 year in county jail, and
  - Fine of \$500 to \$2,000.

**ADDITIONAL PENALTIES FOR DRIVING ON A SUSPENDED OR REVOKED LICENSE**

- 21. I understand the Court may impound my vehicle for up to 6 months for a first offense and up to 12 months for a second or subsequent offense.
- 22. I understand that my vehicle shall be subject to forfeiture as a nuisance if I am convicted of a second or subsequent offense.
- 23. I understand the DMV will suspend my driver's license for an additional 6 months if my offense involved a controlled substance (drug).
