

## What is DPI?

## ENROLLMENT

In order to enroll in our program you must schedule an Intake appointment. Your enrollment will take 35 – 45 minutes. Enrollment appointments are available during business hours Mon – Fri only. Call our office to schedule an appointment.

When you come for enrollment you need to bring the following with you:

- Paperwork from the referring Court. If not yet convicted, you will need your case # or docket #.
- Your violation date. (The date you were stopped.) This is normally listed on the Court referral. If it is not on the referral you may need to get an "H6 print-out" from the CA DMV.
- Your California Driver's License # or California I.D. #. If you do not have either of these you will need to obtain an "X" number from the CA DMV.

**Can I do an expedited program?**

NO, the State of California and the DMV require that you be enrolled for three, six or nine calendar months in order to be eligible to complete. (Title 9, California Code of Regulations)

**What happens if I have to miss a class?**

You can call our office to Re-schedule classes in advance. There is a \$20 Fee and you must make up the hours.

**How and when can I get a restricted license?**

After a 30-day mandatory suspension you must:

- Show Proof of Enrollment in a Drinking Driver Program (DPI files this on-line)
- Request Proof of Financial Responsibility (SR-22) from your insurance company
- Go into your local DMV (in person) and pay the reissue fee

**Where and when can I drive on a restricted license?**

A restricted license allows you to drive to, from & during the course of work and to & from the Drinking Driver Program only.

**If I have a restricted license, once I complete the program do I get my license back?**

The restriction is for five months. You must serve the full five months and show Proof of Completion from the Drinking Driver Program (DPI files this on-line) before receiving your unrestricted license back from the DMV.
